

# Released Prisoner or Inmate Driver's License and Identification Card Information Sheet

## Original

If you were released from the Department of Corrections within the immediately preceding year, or county, city or town jail or detention facility within the immediately preceding 90 days, and would like to obtain a Nevada non-commercial driver's license, driver authorization card or identification card at no cost, you will need to present the following:

- 1. DMV-002 App for Driving Privilege or ID Card
- 2. DP-190 Request for Waiving Fees for Released Prisoners or Inmates and documentation from Department of Corrections verifying your release.
- 3. NDOC Identification Card (if you were not issued an NDOC ID card you will need to present identity documents such as, a US Birth Certificate or US Passport).
- 4. Social Security document, if applicable.
- 5. Immigration documents, if applicable.
- 6. 2 proofs of your Nevada residential address.

#### Renewal

If you were released from the Department of Corrections within the immediately preceding year, or county, city or town jail or detention facility within the immediately preceding 90 days, and would like to renew your Nevada non-commercial driver's license, driver authorization card or identification card at no cost, you will need to present the following:

- 1. DMV-002 App for Driving Privilege or ID Card.
- 2. DP-190 Request for Waiving Fees for Released Prisoners or Inmates and documentation from Department of Corrections, county, city or town jail or detention center verifying your release.
- 3. Previously issued driver's license or identification card if available.
- 4. If you do not have the items listed above the DMV will attempt to determine your identity based on personal information on file, a previous photo and signature.
- 5. Immigration documents, if applicable.

# Duplicate

If you were released from the Department of Corrections within the immediately preceding year, or county, city or town jail or detention facility within the immediately preceding 90 days, and have an unexpired Nevada non-commercial driver's license, driver authorization card, or identification card, you may obtain a duplicate card at no cost. You will need to present the following:

- 1. DMV-002 App for Driving Privilege or ID Card.
- 2. DP-190 Request for Waiving Fees for Released Prisoners or Inmates and documentation from Department of Corrections, county, city or town jail or detention center verifying your release.

#### **Reinstatement of Driver's License**

If you were released from the Department of Corrections within the immediately preceding year, or, county, city or town jail or detention facility within the immediately preceding 90 days and need to reinstate your driver's license or driver's authorization card due to suspension, revocation or cancellation, card at no cost. You will need to present the following:

- 1. DMV-002 App for Driving Privilege or ID Card.
- 2. DP-190 Request for Waiving Fees for Released Prisoners or Inmates and documentation from Department of Corrections, county, city or town jail or detention center verifying your release within the immediately



preceding year.

3. Any other requirements that need to be met under the suspension, revocation, or cancellation withdrawal.

## Examination

Examination fee if required will be waived one-time-only (\$25)

#### The fee waivers do not include Commercial Driver's License or Permits.

The NDOC card cannot be used to prove identity for a REAL ID card.

Any differences in information pertaining to identity or social security will require additional documentation and may include but is not limited to a certified birth certificate, passport, marriage certificate, court order, or Social Security card.

#### **Expiration\***

Applicants aged 65 and older will receive a license with a 4-year expiration upon renewal.

All new applicants under age 65 will receive a license with an 8-year expiration upon renewal.

All new applicants, regardless of age, will receive an identification card with an 8-year expirationdate.

\*There are certain situations where a 4 or 8-year expiration date on a driver's license or identification card is not possible. Please contact your local DMV for more information if you have a medical condition that could affect your driving ability, are a registered sex offender, or if you have immigration documents.
