Dear Director Erdoes,

Pursuant to Assembly Bill 483 of the 2019 Legislative Session, the Department of Motor Vehicles (DMV) is required to conduct a Mileage Gathering Pilot Program which collects mileage, fuel type and body type data for certain vehicle categories. DMV is required to submit a report of the pilot data semi-annually through June 30, 2026.

Attached is the Mileage Gather Pilot Report due July 1, 2023. This report includes mileage collection data for all registered vehicles which reported odometer readings, including intrastate motortrucks and truck-tractors registered with the Motor Carrier Division.

Please reference the footnotes which will provide details explaining the reports and any other exceptions you may not see in the data. Reminder: Due to passage of SB371 in the 2021 Legislative Session, recreational vehicle data has been omitted from the report.

FOOTNOTES:

- 1. Passenger cars are categorized by unladen (empty) weight, as declared weights are not required for registration on these body types.
- 2. Flexible Fuel represents all flexible fuel blends including M85 and E85 as requested in AB483; however, breakdowns of these blends are not available at this time.
- 3. Gasohol (Gasoline) refers to commonly used fuel mixtures of ethanol and gasoline (i.e., E10 or E18).
- 4. PHEV refers to Plug In Hybrid Electric Vehicles, which are reported for purposes of this report as Hybrid Electric.
- 5. Hydrogen is combined with oxygen for use by fuel cell vehicles to run as electric motor.
- 6. Zero mileage data represented. Mileage collection began on October 1, 2019. Odometer reading differences must be excluded which represent only a beginning entry. A beginning entry may show a difference between 0 miles and 110,000 when the vehicle has driven only 9,000 miles in the previous registration cycle, but hadn't previously reported the odometer reading prior to the mileage gathering report.
- 7. Report will exclude the following numerical odometer entries, thereby reducing the population represented (these numbers will appear on exceptions reports for analysis):
 - a. "1" - Representing broken odometer or a vehicle which was originally manufactured without an odometer.
 - b. "2" - Representing no odometer reading report.
- 8. Non-emission required vehicles entering a lower value than entered on a previous registration cycle will be excluded from the report (these numbers will appear on exceptions reports for analysis).
- 9. Potentially misleading data which reduces the validity of the numbers for total miles traveled:
 - a. Under-reporting of odometer reading
 - b. Over-reporting of odometer reading
 - c. Entry errors during customer self-reporting and emission technician processing
 - d. Odometers reported at registration and vehicle sold to be registered out of state in less than 1 registration cycle
- 10. Total numbers of vehicles represents the total number of vehicles currently registered or renewed during this reporting period if odometer readings were reported and the reading was not excluded per footnote 7. These vehicles could be at any point in their registration cycle (12 months) which reduces the validity of using this total to calculate averages. Raw data was provided which does not separate Recreational Vehicles from Passenger Cars, nor does it separate motor trucks and buses from other truck categories (i.e. light-duty and heavy duty).
- 11. July 1, 2022 is the first report which represents total mileage collected for motor trucks and truck-tractors. In effort to provide data for these body types, weight and fuel types, miles reported for motor trucks and truck-tractors previously included only an average number of miles traveled for the timeframe in questions and truck-tractors will include only an average number of miles traveled for the timeframe in question representing only Nevada registered IRP vehicles.
- 12. Potentially misleading data which reduces the validity of the numbers and may show increase or decrease to certain motor-trucks, truck-tractors and buses for the total miles traveled:
 - a. Late registration renewals, motor carrier vehicles are on a staggered registration cycle
 - b. Opening and closing of new motor carrier accounts
 - c. Deletion of vehicles from their accounts
 - d. Delay of processing of end of year registrations (i.e. submissions received in late December are not processed until January and will not appear on the report).

DEFINITIONS:

Light-Duty (2LD) - A truck that has a manufacturer's gross vehicle weight of 8,500 pounds and less, not including a passenger car.

Heavy-duty (3HD) - A truck that has a manufacturer's gross vehicle weight between 8,501 pounds and 26,000 pounds, not including a passenger car, motor truck or truck-tractor.

Motor truck (4MT) - A truck designed for transportation of property, but not manufactured to tow a trailer, with a manufacturer's gross vehicle weight of 26,001 pounds or more; not including truck-tractors.

Truck-tractor (5TT) - A combination motor vehicle designed and used primarily for towing other vehicles and a load/property, with a gross combination weight of 26,001 pounds or more including one or more towed vehicles with a gross vehicle weight of more than 10,000 pounds; not including motor trucks.

Recreational Vehicle (7RV) - A motor vehicle designed as temporary living quarters for travel, recreational or camping use, which is self-propelled.

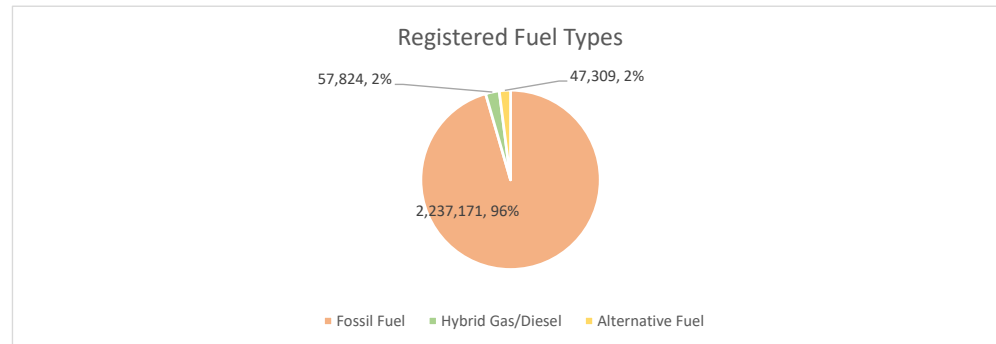
