

DECLARATION OF RESPONSIBILITY NRS Chapters 485 and 482

, declare that, while this vehicle is registered in my name, I will

continuously provide in my name, security as required by NRS 485.185, either by a motor vehicle liability insurance policy or by qualifying as a self-insurer in compliance with law. There is no grace period. NOTE: THE VEHICLE MUST BE INSURED BY AN INSURANCE COMPANY LICENSED IN THE STATE OF NEVADA. The statement, "the coverage meets the requirements set forth in NRS.485.185" must be included on the Nevada Evidence of Insurance card. Out-of-State insurance will not be accepted. Trailers are exempt from insurance requirements.

In accordance with **NRS Chapters 482 and 485**, if the motor vehicle liability insurance on my registered vehicle lapses for one day or more, I understand and agree that I will be required to pay all applicable registration reinstatement fees and fines. If the motor vehicle liability insurance on my registered vehicle lapses for 91 days or more or is the third (3rd) offense, I understand and agree that I will be required to pay all applicable registration reinstatement fees and fines, and I will be required to maintain a Certificate of Financial Responsibility (SR-22 High Risk Insurance) for a period of not less than three years from the registered vehicle, I understand and agree that my driver's license will be suspended for not less than 30 days; I will be required to pay all applicable registration and or fines; and I will be required to maintain a Certificate of Financial Responsibility (SR-22) for a period of not less than 30 days; I will be required to pay all applicable registration and or fines; and I will be required to maintain a Certificate of Financial Responsibility (SR-22) for a period of not less than three years from the registration reinstatement date.
