Restriction Codes and Descriptions				
Code	Restriction	Description		
1	Telescopic Device	This restriction is placed on the driver license of a person who meets the minimum levels of acceptable vision set forth in NAC 483.340 only with the aid of a telescopic device.		
2	Hearing Aids	This restriction may be placed on the driver's license of a person who wears a hearing aid.		
3	No fwy driving	This restriction is placed on a motorcycle instruction permit.		
4	Grip/Power Steering Wheel	This restriction is placed on the driver's license of a person who has difficulty gripping or turning the steering wheel of the motor vehicle.		
5	Directional Signals	This restriction is placed on the driver's license of a person who is physically unable to perform signals with his or her arms or whose driver's license is restricted to hand controls.		
6	Yearly vision exam	This restriction is placed on the driver's license of a person who is required to wear a telescopic device while operating a motor vehicle or a person whose vision is 20/50 or worse in both eyes and who is determined by an eye specialist to have a progressive abnormality or disease of the eye or a person whose vision is 20/100 or worse in one eye and whose vision is worse than 20/40 in the other eye.		
7	Yearly medical Letter	This restriction is placed on the driver's license of a person who has had seizures or episodes of altered consciousness within the last 3 years, or another physical or mental condition that his or her physician determines necessitates a yearly medical examination.		
8	Yearly drive test	This restriction is placed on the driver's license of a person based on the person's performance on his driving test or on the driver's license of a person who is required to wear a telescopic device while operating a motor vehicle.		
9	Seat Cushion/Auto Seat	A restriction is placed on the driver's license of a person who the examiner determines is unable to see adequately out of the windows or reach the control pedals because of his or her size. This restriction is not limited to a seat cushion or automatic seat if another device is available.		
Α	Auto Trans only	This restriction is placed on the driver's license of a person who is physically unable to operate a motor vehicle that is equipped with a manual transmission		
В	Corrective Lenses	This restriction is placed on the driver's license of a person who meets the minimum levels of acceptable vision set forth in NAC 483.341 only with the aid of corrective lenses.		
С	Mechanical/Adaptive devices	This restriction is placed on the driver's license of a person who is physically unable to operate a motor vehicle without the aid of a mechanical or other adaptive device.		
D	Prosthetic Aid	This restriction is placed on the driver's license of a person who is required to wear a prosthetic device while operating a motor vehicle.		
Е	No manual transmission	This restriction is placed on a commercial vehicle if the applicant performs the skills test in a vehicle equipped with an automatic transmission. This restriction can also be placed on a non-commercial class A or B license.		
F	Outside Mirrors	This restriction is placed on the driver license of a person who is legally blind (20/200) in the right eye, whose hearing is impaired, who is required to wear a telescopic device while operating a motor vehicle or whose mobility of his or her head or neck is limited. The restriction may specify the requirement of a right or left outside mirror, outside mirrors on both sides, a wide rearview mirror or a mirror that extends across the entire width of the interior of the windshield.		
G	Daylight driving only	This restriction is placed on the driver license of a person, upon recommendation from a physician, optometrist or opthalmologist, with visual acuity of 20/50 or worse in both eyes, who is required to wear a telescopic device while operating a motor vehicle or who holds a motorcycle driver instruction permit.

ı	Limited Other				
J	Other	This is to be used only if there are no other restriction codes that would apply to what is required given a special circumstance. The use of this code is at the discretion of a supervisor.			
JA	Must Carry Detail Form	If more than 10 restrictions need to be added to a drive record, add only the "J" or "J*" restriction to the detail form. All others should be printed on the card.			
JB	Drive Test Every 6 months	This restriction is placed on the driver license of any person whose doctor requests more frequent driving tests.			
JC	Eye Test Every 6 Months	This restriction is placed on the driver license of any person who is required to have a vision examination every 6 months.			
JD	Drive Fire Equip NCMV A	This restriction is placed on the holder of a CDL class B or C who is authorized to operate a Class A emergency vehicle.			
JE	Drive Fire Equip NCMV B	This restriction is placed on the holder of a CDL class B or C who is authorized to operate a Class B emergency vehicle			
JF	Must Have Wink Mirrors	This restriction may be placed on the driver's license of a person who is legally blind (20/200) in the right eye, whose hearing is impaired, who is required to wear a telescopic device while operating a motor vehicle or whose mobility of his or her head or neck is limited. A wink mirror is a mirror or series of mirrors that extends across the top of the interior of the windshield.			
JG	Motorcycle w-Sidecar	This restriction is placed on the driver license of a person who has demonstrated proficiency in operating a motorcycle equipped with a sidecar.			
JH	Trnsprt Handicapped Only	This restriction is placed on a restricted driver's license issued pursuant to NRS 483.267 permitting a person to transport a member of his or her household who has a medical condition that renders the member of the household unable to drive.			
JI	Drive NCMV A Rec Veh	This is placed on the CDL Class B or C commercial driver's license of any person who has demonstrated proficiency in operating a Class A NCMV recreational vehicle.			
JJ	Drive NCMV B Rec Veh	This is placed on the CDL Class C commercial driver's license of any person who has demonstrated proficiency in operating a Class B NCMV recreational vehicle.			
JK	Left Foot Accelerator	This restriction is placed on the driver's license of a person who is unable to operate the right foot accelerator.			
JL	Trimobile	This restriction is placed on the Class C driver license of a person who has demonstrated proficiency in operating a Tri-mobile			
JM	Class A tow car only	This restriction is placed on the Class A commercial driver's license of a person if he or she completes the driving skills test in a tow car.			
JN	Instruction Permit	Automatically placed on every Instruction Permit issued.			
JO	Driver Educ Only	This is placed on the instruction permit to indicate that the instruction permit is valid for a school year, or more restricted period, and permits the applicant to drive a motor vehicle only on a designated highway or within a designated area, but only when an approved instructor is occupying a seat beside the permitee. (NRS 483.280(3)			
JP	Tow veh >10000 lb CMV C	May tow a vehicle with a gross vehicle weight rating of more than 10,000 pounds only when operating a noncommercial vehicle falling within Class C. This restriction is placed on a Class B driver's license that contains a J endorsement.			
JQ	Tow NCMV <10000 lb <70' (This code will not be used as the R endorsement is no longer available)	May tow a combination of vehicles weighing less than 10,000 pounds and not exceeding 70 feet only when operating a noncommercial vehicle. This restriction is placed on every commercial driver's license that contains an R endorsement.

Code	Restriction	Description			
JR	3 wheel MC w/1 rear pwr wheel	This restriction is placed on the driver's license of a person who has demonstrated proficiency in operating a three-wheeled motorcycle with a single power driven rear wheel.			
JS	Low-Speed Vehicles Only	This restriction will be placed on the driver license of a person who has taken their drive tests in low-speed vehicles (LSV's), whereupon they are restricted to drive only on specially designated roadways posted at 35 mph or less.			
JT	Speed less than 45 MPH	This restriction is placed on the driver's license of a person who is required to wear a telescopic device while operating a motor vehicle or upon the recommendation of a physician or the Department after the administration of a driving test to the applicant.			
JU	Phys Exam Reqd	This restriction is placed on the driver's license of a person obtaining a commercial driver's license.			
JV	NV Med Waiver	This restriction is placed on the commercial driver's license of a person who obtains a waiver pursuant to the provisions of NAC 483.803.			
JW	Dir visual sup 21+ yrs	Must have direct visual supervision by a person 21 years of age or older. This restriction is placed on a class M instruction permit and requires the holder, while operating a motorcycle, to be under the direct visual supervision of a person who is licensed and at least 21 years of age.			
JX	No air brakes	This restriction is placed on the driver's license of a person who does not pass a knowledge test or a driving skills test in a non-commercial motor vehicle which is equipped with air brakes.			
JY	Must carry valid NV NCDL/CDL	A commercial learners permit is invalid unless accompanied by the underlying Nevada non-commercial or commercial license. This restriction will be placed on all commercial learners permits.			
K	CMV intrastate only	May operate a CMV on an intrastate basis only. This restriction is placed on the commercial driver's license of a person who does not meet the requirements set forth in 49 C.F.R. §§ 391.41 to 391.49, inclusive, who is under 21 years of age, or who has self-certified as driving intrastate excepted or intrastate non-excepted.			
L	No air brakes CMV Wgt Only	This restriction is placed on the commercial driver's license of a person who does not pass a knowledge test or a driving skills test in a commercial motor vehicle which is equipped with air brakes.			
М	No Class A Psngr veh	This restriction is placed on the class A or B commercial driver's license and/or commercial learners permit to allow operation of a Class B or Class C passenger vehicle.			
N	No Class A/B Psngr veh	This restriction is placed on a commercial driver's license and/or commercial learners permit to allow operation of a Class C passenger vehicle.			
0	No tractor trailer CMV wgt only	This restriction is placed on the driver's license of a person who holds a Class A commercial driver's license and who completes the skills test in a combination vehicle for a Class A commercial driver's license with the power unit and towed unit connected by connection other than a fifth wheel, such as pintle hook.			
Р	No Psngr in CMV bus	This restriction is placed on a commercial learner permit with a P endorsement and indicates that the holder of the permit is prohibited from operating a commercial motor vehicle carrying passengers other than federal or state auditors and inspectors, test examiners, other trainees and the holder of a commercial driver's license accompanying the permit holder as prescribed by 49 C.F.R. § 383.25.

Code	Restriction	Description	
Q	Moped	This restriction is placed on the driver license of a driver who performs the skill portion of the test on a moped. The driver may only operate a moped as defined by NRS 483.088.	
R	No Plac HazMat or Psngrs	No hazardous cargo that requires placarding or no passengers for hire. This restriction applies to commercial drivers' licenses and is placed on the commercial driver's license of a person who is under 21 years of age, who has impaired vision or who has a clinical diagnosis of epilepsy or any other ailment that is likely to cause a loss of consciousness, unless the person obtains a waiver pursuant to the provisions of NAC 483.803.	
S	No Passengers	No passengers on motorcycle. This restriction is placed on a class M driver instruction permit and prohibits the holder from carrying passengers on a motorcycle.	
Т	To-from school only	This restriction is placed on the driver's license of a person between 14 and 18 years of age who is granted a restricted driver's license to drive to and from school.	
U	MC not to exceed 90 cc	This restriction is placed on the driver's license of a driver who performs the skill portion of the test on a motorcycle which has 90 cubic centimeters or less. The driver may only operate a motorcycle having 90 cubic centimeters or less.	
V	Med Variance Docs Reqd	This restriction is placed on the commercial driver's license of a person who has been issued a federal medical variance.	
W	Farm Waiver	This restriction is placed on the driver's license of a farmer or an employee or family member of a farmer and allows the person to operate a farm vehicle to transport agricultural products, farm machinery or farm supplies to or from a farm within Nevada and within 150 miles of the person's farm. The person shall not operate a motor vehicle in the operation of a common or contract motor carrier with a Class A or Class B noncommercial dirver's license.	
Х	No cargo in CMV tank veh	This restriction is placed on a commercial learner permit with an N endorsement and indicates that the holder of the permit may only operate an empty tank vehicle and is prohibited from operating any tank vehicle which previously contained hazardous materials that has not been purged of any residue.	
Y	Ignition interlock	This restriction is placed on the driver license of any person when the department has received a copy of a court order requiring the person to install a device in a motor vehicle that he owns or operates pursuant to NRS 484.3943 or if the person is required to install such a device pursuant to the provisions of the laws of another state, the District of Columbia, any territory or possession of the United States or any other country.	
Z	No Full Air brake Equip CMV	This restriction is placed on the commercial driver's license of a driver who performs the skills test in a motor vehicle equipped with air over hydraulic brakes.
