## RETIRED MILITARY VEHICLE REGISTRATION APPLICATION NRS 193.130, 482.290, 482.3817 & 485.185

### Important Information:

- The vehicle registration must comply with Nevada Revised Statute <u>482.3817</u>.
- The vehicle must comply with the insurance requirements per Nevada Revised Statute <u>485.185</u>. A copy of proof of insurance must be supplied with the registration application.
- Application must be accompanied by proof of ownership satisfactory to the Department.
- Any vehicles without an assigned Vehicle Identification Number (VIN), are required to have a DMV VIN inspection and assignment of a unique VIN, per Nevada Revised Statute <u>482.290</u>. The VIN report must be included with your application or it will be rejected and returned to you. A VIN inspection is also required for persons titling or registering their vehicles in NV for the first time. **License Plate Request**

# Initial registration request:

- The completed application and fees must be sent to the Carson City DMV ATTN: Special Plates 555 Wright Way, Carson City NV 89711. The registration and license plates will be mailed to you in 4-6 weeks.
- Payment can be submitted by check, money order, cashier's check or by using the Payment Authorization form (ADM-205). Please do not send cash.
- Registration and Renewal Fees

#### • Initial Registration Fees:

- Vehicle or trailer with large plate: \$25.00 registration fee, \$1.00 prison industry fee, totaling \$26.00.
- Motorcycle or trailer with small plate: \$25.00 registration fee, \$0.50 prison industry fee, totaling \$25.50.
- Registration Renewal Fees:
  - \$10.00 registration renewal.
  - o Registration renewal can be done online, at a DMV Kiosk, by mail or at a DMV office.
