PEACE OFFICER LICENSE PLATE APPLICATION

NRS 482.3757

A current, former, or family member (a widow, widower, parent, stepparent, grandparent, child, stepchild, dependent, sibling, half sibling, or stepsibling) of a <u>peace officer of any US state, including the District of Colombia, who has been awarded decorations</u> listed below while on active duty may apply for up to 2 sets of Peace Officer license plates <u>with proof satisfactory to the Department of Motor Vehicles.</u>

- The Medal of Honor;
- The Purple Heart;
- The Medal of Valor;
- The Lifesaving Medal;
- The Meritorious Service Medal;
- The Distinguished Service Medal; or
- The family member of a person who was killed in the line of duty while serving as peace officer and awarded posthumously the Medal of Honor, or the equivalent thereof, for his or her actions as a peace officer.

Peace Officer license plates are available for non-commercial vehicles and are available as personalized license plates (see page 2). The individual ordering this plate must be a registered owner on the vehicle. If your vehicle is currently registered, you have the option of maintaining your current vehicle registration expiration date or renewing for a full 12-month period. Credit for any unused portion of your current registration will be allowed. In applicable counties, if you are renewing for a full 12-month period and your pervious evidence of compliance with emissions standards was obtained more than 90 days ago, a new emission test must be performed on the vehicle prior to registration. Nevada evidence of insurance must be presented at the time of registration.
